### HOW TO REGISTER

- 1. **Registration Form:** Parents Must fill out both sides of the registration form fully, Parent and Child must sign and mail original to our office. Please print, using ONE REGISTRATION PER CHILD.
- 2. **Medical Release Form:** Form can be printed out from our website or you may call office and have one faxed or mailed to you. Form must be completed, signed and sent with registration form.
- 3. **Participant Agreement Release Form:** Form can be printed out from our website or you may call office and have one faxed or mailed to you. Form must be completed, signed and sent with registration form.
- 4. **Deposit:** A deposit of \$200.00 +\$14.00 tax is required to be sent with the registration form. This is a non-refundable deposit. Balance is due 2-weeks prior to the date of attendance.
- 5. **Check or Money Order:** Made payable to: "Diamond D Ranch Inc." and WRITE THE CAMPERS NAME ON THE CHECK. We will not be responsible for cash sent through the mail.
- 6. **Credit Cards:** You may pay your deposit or the entire amount of camp by credit card. We accept Visa / MC / Discover Card.

#### RULES

Campers are not allowed to leave camp, or their counselor, without permission, under any circumstances. Profanity will not be allowed or tolerated while at camp. No cell phones are allowed to be brought to camp, no exceptions. The use of tobacco products, alcohol and/or drugs are prohibited. Other rules not stated will apply at the time of camp. The breaking of these rules is considered a serious offense and parents will be notified. Being dismissed from camp is a distinct possibility for children who break the rules. Also, children who are unruly or pose undue disciplinary problems may be dismissed. No refunds will be offered or given. No exceptions.

#### PHONE CALLS

Part of the experience of being at camp is learning to be self-sufficient away from home. Therefore, we do not allow campers to initiate phone calls home during their stay, unless there is an emergency and/or otherwise instructed by the counselor. No cell phones are allowed to be brought to camp. No exceptions.

#### OFF CAMP RELEASE:

The previously named camper has my permission to be transported and participate in outings and field trips that may be conducted off the Diamond  Horse Camp grounds. It is understood that these outings are fully supervised by qualified camp staff.
